1. This is a Hq USAF directed reassignment.
2. This is a Hq AFCS directed reassignment. AFO making pmt & TO issuing TR or BL will furnish cy of pd voucher, TR & BL to Hq AFCS (CSAAFB), Scott AFB, I11 62225. All TO & AFO processing documents against this SO will include in the fund citation the FCN
3. Indiv will rpt to Base Transp Off before departing unit of assignment to obtain DD Fm 1482 (Mil Transp Auth), or if Category "Z" travel is directed, obtain reservations, TR & necessary tickets.

Commercial buses at no expense to indiv are provided from San Francisco to Hamilton AFB and depart all rail, bus and air terminals. Bus from Hamilton AFB to Travis AFB is provided.
